

Picture two professors in their office, lamenting the fact that fewer and fewer international artists were coming to Kansas City. The year was 1965, and the dearth of rich cultural opportunities was mounting. Kansas City was no longer a stop on the tours of most world-class artists.

As they talked, those two English professors—Richard Harriman and Dean Dunham—decided that William Jewell College should help make Kansas City's cultural life sparkle once again. Itzhak Perlman, Marilyn Horne, Luciano Pavarotti, Cecilia Bartoli, Juan Diego Flórez, and Joyce DiDonato have all taken bows on the Series' stages before they became legends.

For 45 years, Richard carefully guided the Series, nurtured new artists, fostered arts audiences and brought the very best of the performing arts to Kansas City's audience. This was his legacy, his life's work, and his passion.

Common Giving Options

Bequest — A time-tested means of making significant planned gifts

A bequest in your will is perhaps the most basic and flexible of estate-planning instruments. The legal document specifies one's wishes concerning one's estate at death and provides detailed instructions for disposing of assets accumulated over a lifetime. Many of our friends have chosen to name the Series as the recipient of a specific percentage of their estates and, in some cases, have given far more generously than they would have thought possible. Still others have bequeathed to the Series a specific amount.

Gifts that Provide Income—Charitable Gift Annuities and Remainder Trusts


A charitable gift annuity is a binding contract between a charitable, nonprofit institution and an individual who wishes to make a donation to the institution in exchange for a guaranteed income for life. Since income is to be paid for life and payments are guaranteed, the life expectancy of the annuitant becomes a central factor in calculating the payment amount. With a charitable remainder trust, an individual can receive income each year for the rest of his or her life from assets given to the trust. The income can be either variable or a fixed amount. After your lifetime, the balance in the trust goes to the charities of your choice.
